**2. DEFINITIONS**

The following terms used in this Notice shall have the following meanings:

- 2.1. Service Provider: the person providing service in connection with information society.
- 2.2. User: any person who uses the Website or the services available on the Website (for example card registration) in any way.

**3. BASIC PROVISIONS:**

- 3.1. Issues not governed by these Provisions and the interpretation of this Notice shall be governed by Hungarian law, with particular reference to the Act V of 2013 on the Civil Code ("Civil Code") and the Act CVIII of 2001 on Certain Issues in Electronic Commerce Services and Information Society Services (Electronic Commerce Law). Binding provisions of the applicable law shall apply to the parties, without any further stipulation.
- 3.2. This notice shall be effective from December 5, 2019 and shall remain in effect until revoked. The Service Provider has the right to unilaterally amend the Provisions. The Service Provider shall publish the changes on the website 11 (eleven) days prior to their entry into force.
- 3.3. In case the User entered the Website operated by the Service Provider or read its content in any way, they acknowledge that they are bound by the Provisions. If the User does not agree to the Provisions, they are not entitled to view the content of the Website.

- 3.4. The Service Provider reserves all rights to the Website, any part thereof and the contents appearing on it, as well as the distribution of the Website. It is prohibited to download, electronically store, process and sell the content or any part of it on the Website without the written consent of the Service Provider.

#### 4. DISCLAIMER
